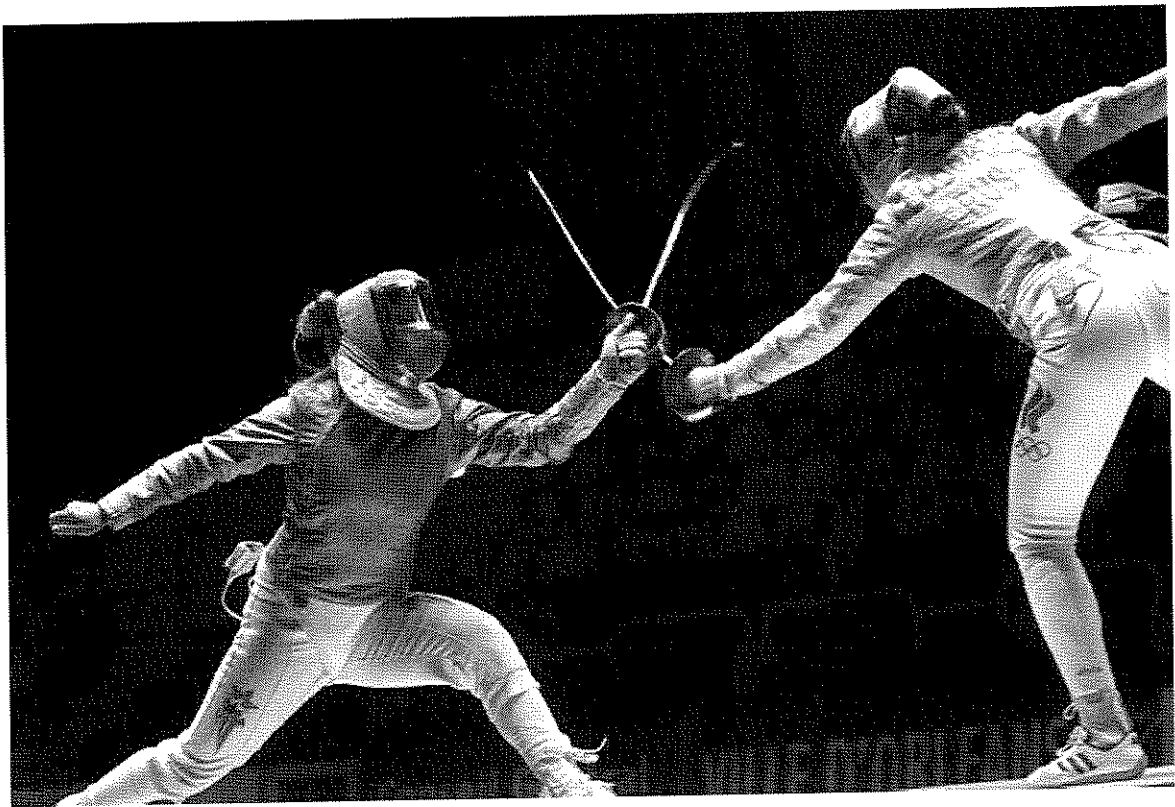


Fencing

Local and regional competitions occur regularly throughout the year. Several non USFA competitions will be held each year by North Florida Fencing Academy, as well as many Official tournaments throughout the year locally and throughout the region. Official tournaments will require a USFA membership and a full set of personal equipment. The equipment price listed above includes protective equipment suitable for competition. Electric equipment will need to be purchased in addition for competition if desired. Equipment may be borrowed from NFFA on a first come first served basis for local tournaments.

*In the case of multiple participants that are siblings each additional participant will be half price. This only applies to the Semester lesson fee, not weekly fees or equipment fees.

A plastic chest guard (Woman's models are available and encouraged in particular). ~\$25.00.

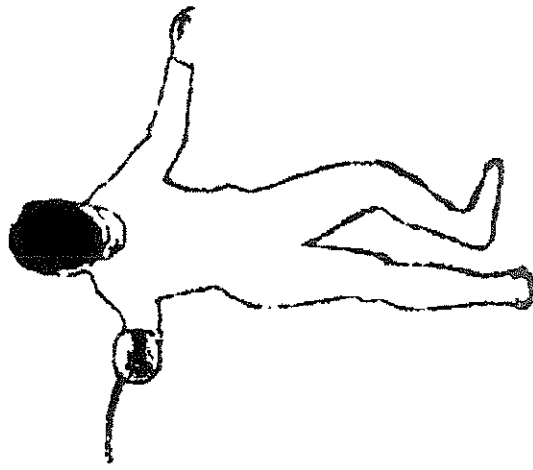
Or insert-able breast protectors (plastic or aluminum cups intended to be worn in slots built into woman's jackets). ~\$7.00
